

For several years Peggy and I have been planning a trip with our kids and grandkids to celebrate our upcoming 50th anniversary. It's not until September but with the two oldest grandkids in high school, we decided we better use this recent Christmas Vacation to get everybody together. **Costa Rica** was our destination. Maneuvering our party of 12 through all the

transportation connections went pretty well. Our first stay was in Tamarindo, a beach community on the Pacific Coast. Our second stay was in Tortuguero in the rain forest, reachable only by boat or plane. And the 3rd leg of our journey was a stay at the foot of a volcano, Arenal, near the town of La Fortuna. Lots of European, American, and Asian tourists. American money accepted happily virtually everywhere; no Montezuma's Revenge—drank tap water everywhere we stayed and ate fresh fruit--, all tourist-related folks spoke English, but I had a lot of fun speaking Spanish with our guides and drivers and they were accommodating conversationalists. So I asked the rest of the family, "who wants to go?" Our 2 grandkids from Elk Grove and our eldest from Visalia said they wanted to go. So off we went in a taxi up through the town on dirt roads into the hills. The man that set it up didn't go with us so I was a little nervous, hoping this whole deal was on the up and up. His "brother" got up on his horse after helping the grandkids mount theirs, and off we went. I decided I better ride in back because "Fernando" never looked back. A little different than the highly regulated rent-a-horse industry we've come to expect in California. No helmets, no safety briefing, no nothing. And we were off at a trot. And we trotted on the 2 hour ride a lot more than we walked. I was worried about the grandkids because they don't ride except rarely at our annual family camping trip to Cedar Grove. But they laughed, waved their arms, and tried to get ahead of each other as we rode the hill trails and dirt roads of Tamarindo. I'm so glad I took **Kyle, Grayson**, and **Taylor** horseback riding on this family trip and am sure it will be something they remember doing with their ol' grandpa.




4th Annual Shoot Your Heart Out!



Rides by Tara February-March



February 16th - Hensley Lake/Buck Ridge Ride 10 am

This is a nice 2-3 hour ride including time for lunch break. This trail runs alongside the lake, some parts of the trail offer very pretty views of the lake. Wide to narrow dirt trails, some rocks and climbs. This trail is shared with bike riders and hikers. Might have small water crossings. There is a four dollar day use charge. Large parking area with picnic benches and bathrooms. Please RSVP to **Tara Stephenson** by February 13th at either Tara1Stephenson@aol.com or call her at 559-977-2766, at that time, she can give you directions and answer any questions.

February 23rd - Coffman Ranch Ride 10 am

Always a nice ride at the Coffman Ranch! Ten dollar haul in fee which includes use of their arenas, round pens; heck, we can even give our horse a warm water bath if we are so inclined after the ride. The ride will be about 2-3+ hours including a lunch break. The Coffman Ranch has some nice single track trails to follow or we can just amble about if we are in the mood to do so. Located in the foothills so there will be little bits of climbing along the trails as well as cattle roaming around. Please RSVP to **Tara Stephenson** by February 20th at either Tara1Stephenson@aol.com or call her at 559-977-2766, at that time, she can give you directions and answer any questions.

March 2th, Lewis P. Eaton Trail/Woodward Park 11 AM (Be in the saddle at 11 AM) Wow, talk about exposure, you and your horse will see EVERYTHING on this ride, not to mention going over a few suspended bridges. We will be parking at the trailhead which starts at the Coke Hallowell Center on Old Friant Road. From there, we will begin our 3+ hour adventure along the bike/walking trail known as the Lewis P. Eaton Trail. On this paved trail, you will encounter cyclists, runners, walkers, mom's with baby carriages, dog on leashes, loud noises coming from Friant Road and the nearby gravel company. As we get into the park area, we move away from those things heading down to the river to give our horses a drink, tie up to a tree for a lunch break on picnic tables with nearby bathrooms. After lunch, for those of us that wanna let our horse "break loose and lope", we can use the tracks down by the river to have a nice lope around. For those of us that would prefer to just walk, we can do that as well. Then we'll return the way we came back to the trailers. This is NOT a ride for spooky, green horses. March 9th, Avocado Lake/Orange Orchard Ride, Part 2 11 AM

(Be in the saddle at 11 am). Back by popular demand, we will return to the lake for some more **conditioning**. This ride will be 4+ hours. We will of course eat our lunches at the lake, but this time, we will be spending more time out in the orchards, where we can climb the hills and cross the little rivers that run through the orchards. This time we will head farther east where there are more opportunities to climb and traverse. On this ride, you will be exposed to farm workers and machinery out in the orchards as well as an occasional pig, coyote and jack rabbit. There is a \$5.00 fee to enter and park at Avocado Lake. March 30th, Millerton Lake/Madera Side Ride, Part 2 11 AM

(Be in the saddle by 11 am) Also back by popular demand and due to the limited trailer parking, we are offering this ride again to those that weren't able to make it to the first ride we had up there! So again, please RSVP right away so that you can be one of the 10 trailers we can fit into the parking lot. An easy dirt trail that goes from the horse corrals on the north side back a few miles around the lake and then back. Approximate length of ride 2-3+ hours including a lunch break. There might be hikers and or bikes on this trail. There might also be car traffic alongside some areas of the trail. There is a ten dollar admittance to the lake. April 20th, Revis Mountain Ride, 11 am

(Be in the saddle by 11 am). Woo hoo, finally we get a chance to ride up here, we've been trying to get a ride going up here but kept getting rained out so let's cross our fingers for this one! We welcome you to join us for a 3 to 4 hour trail ride in the hills of Yosemite Lakes Park. We will park at the Equestrian Center parking lot at Yosemite Springs Parkway and Longhollow Drive. Overflow parking is available at the Recreation Center a bit further down Longhollow. We will be ascending Revis Mountain. The trail is mostly dirt road footing with some asphalt street crossings and rock step-overs. The ride is very challenging for the horses due to climbing the mountain. There are a few steep areas. This ride is suited for intermediate riders and horses that are in good shape. We will see mountain views and one or two small creek crossings. There are occasional hikers with dogs on leashes and very seldom we see a bicyclist. Bring your lunch, we will be tying up and eating on the trail and a bucket to water your horse after the ride. Water is available at the Equestrian Center. For future reference, visitors are allowed to ride in YLP only if a resident of YLP accompanies them. BCHC San Joaquin Sierra Unit's First Ride of 2013

Saturday, January 12th, 2013, 25 horse & rider teams participated in the first ride of our season! It was a nippy 35 degrees, mostly clear and sunny at Avocado Lake which is a 210 acre county park, located 23 miles east of Fresno off Hwy 180.

Trail Boss, **Tara Stephenson** chose this area for the first ride of the year, because of the great 'conditioning' terrain it offers. In addition, Avocado Lake has amenities such as firepits, restrooms, picnic tables, paved access in & out. For many horses & riders, it was a nice way to 'ease' the transition back into the saddle, after some time off over the holidays.

Before the ride started, **Ted Fischer & Tara Stephenson** gathered riders together for an Education Clinic regarding gentle use of the lands on which we ride, LNT (leave no trace), and general trail safety. The group was then split into two smaller groups, leaders and drag leaders assigned, and the ride(s) commenced. After riding the perimeter of the lake, we stopped back at the horse trailers and ate lunch together. A good time was had getting to know the new members and visiting with friends.

After lunch we went back out; riding away from the lake where the terrain is less varied (everything looks 'the same'). An hour into the ride, a few riders had become 'turned around'. This brought to light an awareness of the need for rider re-education [brushing up on] directional training; landmarks, map reading, compass use, etc, before packing into uninhabited higher elevations.



Objectives & Purpose of the Backcountry Horseman of California

From the BCHC Bylaws

- To improve and promote the use, care and development of California backcountry trails, campsites, streams and meadows; to advocate good trail manners.
- To promote the conservation and utilization of our backcountry resources in concert with livestock transportation.
- To keep the backcountry trails and forage areas open to horseman on all public lands.
- To keep current information before the Corporation membership and its local Units regarding new legislation or management plans related to government regulations of the backcountry.
- To support or oppose new proposals, plans and restrictions as related to the interest of horsemen and those persons interested in recreational stock use and enjoying the backcountry.
- To promote the interest of people who, due to health or physical factors, need transportation other than by foot on backcountry trails.
- To promote public awareness and interest in the historical aspect of horsemen and stock in the backcountry and to help educate backcountry users on the ways to use the trail and foraged in a manner that conserves the backcountry resources.
- To assist in keeping the public informed of the vital need for a clean backcountry.
- To promote a working relationship with and keep the work and interests of the Corporation before our local, state and federal officials.
- To assist in the formation and continuation of local Units to carry out these purposes.
